I want to be able to set the height of each one of these subviews as well as their top margin. However, when I try to do this, the subviews appear to be resized to fit the height I have assigned them. When I delete the height, then they appear to be resized to fill the scrollview's bounds. Is there a way to disable the automatic resizing of subviews? A: There are two possibilities: First, turn off autoresizing: `theView.autoresizingMask = .FlexibleLeftMargin | .FlexibleHeight | .FlexibleWidth`; Second, manually specify the frame: `theView.frame = CGRectMake(viewOrigin, viewOrigin + viewWidth, viewWidth, viewHeight)`; Where `viewOrigin` is the origin of the view (either a corner, or top-left, depending on your frame settings). `viewHeight` and `viewWidth` are obviously the view's height and width, in pixels. Petitioner seeks review of an order of
the Department of Consumer and
Commercial Services (DCCS) that
denied his application for
unemployment benefits for refusal to
work because of a job-related illness.

The trial court affirmed the DCCS order. We affirm. Petitioner resigned from his full-time position as a principal teacher for a charter school. He applied for unemployment benefits because the school's principal, another teacher and two principals' aides told petitioner that he would not be working at the school but would be on sick leave. Petitioner worked another full-time job and asked for three months of sick leave but the school decided to terminate his employment. The contract between petitioner and the school provided for sick leave for two years. The school notified petitioner of its decision in writing on March 15, 1991. The school's assistant director sent the

letter to the DCCS office, asking that any sick leave payments be held in escrow until the issue of whether petitioner was entitled to unemployment benefits was resolved.

The DCCS assigned an appeals examiner to petitioner's case. At the *1039 hearing, the appeals examiner considered petitioner's claim for sick leave benefits and decided that, because petitioner was unable to work due to an on-the-job injury, his application for benefits should be denied. The appeals examiner found that the record showed that petitioner's employment was subject to the provisions of ORS 6
